TILLAMOOK BAY COMMUNITY COLLEGE CELEBRATES MILDRED DAVY DAY IN LIEU OF LUNCHEON

The TBCC Foundation Board hosts an annual Mildred Davy Scholarship Recognition Luncheon to bring together donors, college supporters, and students.

This year, the TBCC Foundation Board once again chose to cancel the in person event, but still wanted to recognize all of the people who make scholarships possible – starting with Mildred.

"Mildred Davy was a huge advocate for higher education," said Britta Lawrence, TBCC Development Director. "She never stopped championing the cause."

"In 2002, the TBCC Foundation was honored to start its very first endowment in her name and we continue to celebrate all that Mildred has done for our college and our community."

That endowment started with donations from 57 of Mildred's friends and family members, who raised \$19,000 to get it started. Today, the endowment has grown to more than \$168,000 and has supported 43 students



since its inception.

On Nov. 17 The Board celebrated 'Mildred Davy Day'. A special 'Mildred Davy Day' radio program aired on 95.9 KTIL. The community heard from scholarship recipients, long time TBCC

Foundation supporter and friend of Mildred, Van Moe, and some previously recorded clips from Mildred's own radio program "It's a Woman's World". This Tillamook Today program is available on Tillamook Today's podcast website www.podcasts. com/tillamook-today-onktil.

The TBCC Foundation Board also distributed yellow roses, Mildred's signature, at different businesses located in Tillamook. The Foundation would not be able to assist TBCC students to reach their educational goals without the support from our donors, and community supporters.

TBCC Awarded Grant from Roundhouse Foundation

This fall, the Tillamook Bay Community College Foundation was awarded a \$15,000 grant from The Roundhouse Foundation to support students enrolled in a Career-Technical Education Program. The grant helps cover costs associated with equipment and program fees.

"The intent is to lessen the barrier for these students to participate in these programs," said Britta Lawrence, Development Director for the TBCC Foundation. "This is the inaugural year this grant has been funded, and TBCC feels very lucky to have been selected as a recipient."

The TBCC Foundation has already awarded close to \$3,000 of the grant this fall to assist TBCC Students. Lawrence said students do not need to apply for the funding; it is automatically credited to their account when they enroll in a qualified CTE program.

The grant helps students who may need things like boots or gloves for welding; scrubs and stethoscopes for the healthcare programs; and fingerprinting, and licensing requirements for EMTs, among other things that a student would typically have to pay out of pocket for.

Tillamook Bay Community College has CTE degrees and certificates in the fields of healthcare, welding, manufacturing and industrial technology, agricultural technology, criminal justice, and business administration.

Roundhouse Foundation Grant Recipient: Jimmie Cope

Jimmie Cope was born and raised in Beaver.

"I left here in the late 70s after my mom passed," Cope said. "I came back [to the area] three years ago."

In 1996, Cope received his GED and recently had been working in the veterinary medical field, but decided he wanted to make a career change.

"I think it would be really neat to build my own motorcycle frames," Cope said. "I have a goal to achieve a certificate in welding. [With that certificate], I can do underwater welding, work in shipyards, manufacturing in general. I also want to continue my education and see where I can go from there."

Technology Certificate will prepare students for a career in welding and welding related fields. The program covers Shielded Metal Arc Welding (SMAW) and introduces Gas Tungsten Arc Welding (GTAW), Oxy-Acetylene, and plasma Cutting. Students will be prepared to enter welding careers in Industrial Welding, Marine Welding, and Food Industry Welding. In addition, students will be prepared for welding related career fields such as Industrial Millwright, Structural Maintenance, and Agricultural Mechanic.

"The instructors of my courses are very knowledgeable, encouraging, and helpful," he said.

Cope is currently enrolled full-time at TBCC as well as working for the City of Bay City as a code enforcement officer.

"Don't let your fears get in your way," Cope said. "If you do, you'll be miserable in what you're doing, by the time you get up in age like me. You will think, 'Why didn't I do this earlier?'"

To help support his dreams, Cope is a most recent recipient of TBCC's new Roundhouse Grant that is distributed to all CTE program registered students.

"I'm honored, proud, and privileged to have something to help me move forward with my dreams," Cope said. "I hope to show others that no matter how old you are it's never too late to start."

Isabella's grandmother lived in Tillamook and she decided to relocate from Portland. Isabella toured TBCC and was awarded a Career-to-Career Scholarship.



After a 20 year break from school, LeAnne Troyer began her career change at TBCC last year.

"I did daycare for several years so that I could stay home with my babies, but also contribute financially to the family," LeAnne said. "But I wanted to work towards something that I wanted to do forever."

LeAnne is the recipient of a Career-to-Career Scholarship and Arthur and Janet Riedel Endowed Scholarship.

The Career-to-Career scholarship was formed to help students who are returning to school after already being a part of the workforce for several years. It was created out of an effort to make sure that every student has what they need to complete their education without the stress of financial burden. "Funding is available and I'm very grateful for the financial help," LeAnne said. "It really has made the difference."

In addition to being a full-time student, LeAnne is also a mother and works part-time as an education assistant for Tillamook School District.

"My advisor has done a really good job at guiding me," LeAnne said. "They're really here for you as a person, and good at accommodating and considering your schedule and family."

LeAnne will complete her Associate of Arts Oregon Transfer degree in the spring of 2022 with the hopes of transferring to a physical therapist assistant program in the future.
