the creation of a Hampton Lumber
Scholarship endowment for
Tillamook Bay Community College
(TBCC). The endowment will
provide scholarships for students in
TBCC's forestry and manufacturing
and industrial technology (MIT)
programs.

"The health and vitality of our communities has always been a priority for Hampton," said

Hampton Lumber CEO, Steve Zika. "Ensuring opportunities and career pathways for local youth is big part of that."

While Hampton already offers undergraduate and trade school scholarships to children, spouses, and domestic partners of employees, the TBCC scholarship is the company's first public educational endowment.

Hampton has operated a mill

in Tillamook since 1986 and was a founding partner in TBCC's MIT program. TBCC's Associate of Science degree in Forestry program was launched in 2018 for students interested in transferring to a four-year program in Forestry.

"The TBCC Foundation Board of Directors feels incredibly grateful to strengthen our partnership with Hampton Lumber," Britta Lawrence, Executive

The event celebrated 38 students who were honored as recipients of the 2022-23 endowed and named scholarships. Director of TBCC Foundation said. "Endowments exist into perpetuity, and this gift will be impactful to Ag, Forestry, and Natural Resource students forever. We are so appreciative to have Hampton Lumber as a community supporter."

In addition to the Tillamook sawmill—one of four Hampton mills in Oregon—Hampton also owns roughly 100,000 acres of timberland in northwest Oregon to help supply these mills. The majority of the timber supply for the Tillamook mill, however, comes from surrounding private and public working forestlands, including the Tillamook State Forest.

"Northwest Oregon is one of the best places in the world to grow and manufacture wood products and demand for lumber for housing and other projects is increasing steadily," said Zika. "There are lots of local opportunities for young people looking to make a career in the forest sector and we hope this scholarship helps students understand and access these opportunities."

Students will be able to apply for the scholarship beginning in spring 2023.

Hampton Lumber is a fourth-generation, family-owned company headquartered in Portland, OR. Founded in Willamina, Oregon in 1942, Hampton operates ten sawmills in Oregon, Washington, and British Columbia and markets wood products all over the world. All of Hampton's forestlands are certified by the Sustainable Forestry Initiative (SFI), an independent, non-profit organization that promotes sustainable forest management. SFI certified forests play an important role in water conservation, wildlife habitat, and climate solutions.

Alumni Highlight: Robin Finnell

After working in the same position for several years for the Tillamook County Creamery Association, Robin Finnell was looking to make a change in the company.

"I applied for a different job in the business...at that time the culture was very degree-oriented," Robin said. "There were two different jobs I had applied for. I had all the applicant qualifications: I knew the job. I knew the business area. I knew the process. But, I didn't have a college degree and they wouldn't even interview me."

Post-high school, Robin wasn't able to attend college as she worked to balance motherhood and a full-time job.

"I was single mom for a lot of years," she said. "I got out of high school and went to straight to work, so I didn't go to college. I tried at first: I signed up for community college classes, but trying to work and having a baby just didn't work."

Knowing she needed to obtain a degree in order move up within the Creamery, Robin reached out to Tillamook Bay Community College and began to plan out her future.

"I mapped out everything I would need for a four year-degree," she said, adding that the Creamery has wonderful educational benefits to help employees further their education.

Robin began her journey at TBCC in 2011 and earned her Oregon Transfer Degree in Business. She went on to earn her Bachelor's in Business Administration with a concentration in accounting from Eastern Oregon University.

"TBCC offers a large selection of educational tracks; it's amazing from that standpoint," Robin said. "Especially in a rural area like ours, TBCC is amazing. It's reasonable: as an adult it's convenient for you to work full-time and take classes at night or during the day."

Robin said she knew the credit cost could be prohibitive in her achieving her goals, but found incredible support from TBCC and the community.

"Money was always an issue: I didn't ever have much of it," she said. "I was lucky to go back. I was able to apply for loans and grants, and was lucky to have that. By the time I was done at TBCC, I had paid out of my own pocket for two classes which was great. I can't tell you how great TBCC was at mapping that out from the beginning."

With her new degrees, Robin was able to advance up through the Creamery and closed out her 16.5 years with the company as Master Data Architect.

"I appreciate the community that we live in and think we're amazing," she said. "We come together for so many things. I really appreciate that we have the college and offer the things that we do."

She credits TBCC for helping further her career, and encouraged her own children to get their start at TBCC.



TBCC Alumni Robin Finnell spent 16.5 years employed with Tillamook Creamery and advance up through the company with the help of a degree from TBCC.

"TBCC offers kids an opportunity to start college in high school so they're earning dual credit," Robin said. "My kids went as First Class Scholars. It cost them essentially nothing: at the end of two years, they walked away with a degree. For parents who are struggling and don't have the option to save and send their kids to college, this is huge."

Robin has seen the positive results of community backing and encourages those who are able to support any way they can.

"The more help we can get and the more community grants and scholarships that we can make available to the kids in the area, will allow them more opportunities. That's amazing."

Help us support our students in times of need

In 2019, The Hope Center for College, Community, and Justice at Temple University completed its Hope Survey on the students at Tillamook Bay Community College.


In comparison to the rates for all survey respondents at twoyear colleges nationwide, TBCC has a higher rate of food and housing insecurity and a higher rate of homelessness. The TBCC Foundation is focused on finding ways we can support our students.

The survey found that 53% of respondents experienced food insecurity, and many were afraid their food would run out before they had the funds to purchase more. In the same year, 60% of students experienced housing insecurity, while 27% experienced homelessness. All of which can drastically affect someone's academic and personal life.

The TBCC Foundation can help provide resources for students to access food and supplies through the TBCC Food Pantry, bus passes and gas cards for transportation assistance, shower vouchers for the YMCA, and backpacks for emergencies containing items such as toiletries, diapers, socks, and laundry detergent.

But we can't do it without help from our community. The TBCC Foundation has emergency funds in place to support students suffering from basic needs insecurity. With your contributions, students at

TBCC will have access to plentiful support programs that help see them through the pursuit of their education and dreams.
