

### The Richard & Virginia White Educational Fund

This year, the Tillamook Bay Community College (TBCC) Foundation was gifted \$773,000 from the family estate of Richard and Virginia White—the largest single donation in the Foundation's history. As artists, supporters of education, and Tillamook locals, Richard and Virginia wanted this generous gift to have a lasting impact on the community.

Richard White grew up in Tillamook on McCormick Loop and attended South Prairie School when it was an all-grades school. He graduated from high school there, joined the Navy, and then came home to work and save money for college. An artist at heart, Richard was also a passionate cartoonist and submitted some of his cartoons to the Headlight Herald. When he had saved enough money, Richard went on to enroll at Lewis & Clark College.

Donna Kaser, Richard's sister and trustee of the White Family Estate, recalled when Richard left for college, "We couldn't wait for him to come home. He had a dog that would lie out on the street waiting, sometimes two or three days at a time." She also remembers Richard's passion as an artist and how that passion connected him with his wife, Virginia.

"They met at Lewis & Clark, they were both studying art, and

married before they graduated," said Donna. Richard taught Virginia how to draw cartoon characters, and in 1964, they traveled to the World's Fair in New York from their home in San Diego, drawing along the way. Richard also designed stamps, did glassblowing, and made dummies as a hobby. "He was such a creative man; he could do anything and could always find a way to fix or make something."

While there was no community college in Tillamook when he was growing up, education was always important to Richard, and this value was also shared by Virginia. "When [he] passed, the trust was split, and his half was always meant for TBCC. He felt it was something he would like the college to have, something to help students," Donna said.

The TBCC Foundation will honor Richard and Virginia White's generosity by using this remarkable gift to strengthen opportunities for local students for years to come. "We are deeply grateful for the White family's belief in our mission," said Britta Lawrence, the Executive Director of the TBCC Foundation. "This incredible gift will open doors for generations of TBCC students."

The funds will support scholarships for TBCC students and open doors for learners in Tillamook County, ensuring that Richard and Virginia's passion for education and the community continues to shape futures.

### Remembering Van Moe

"Patsy and I remember Van Moe as a man who believed that availability of higher education was a key element to the success of our community. Van was a member of the Northwest Regional Economic Team who believed that economic development and education were partners in the success of our community. He worked with State Senator, Betsy Johnson continuously to promote TBCC. The opportunity for local citizens to better their lives was ingrained in Van.

As the owner of Radio Stations KTIL and KMBD, Van Moe was a strong advocate for Tillamook Bay Community College. With the help of Mildred Davy, the two of them took every opportunity to promote the college as a gem for Tillamook County. Mildred Davy hosted the show "It's a Women's World" every weekday and TBCC was a topic on the show several times each month.

In 1997 Van was instrumental in creating the Tillamook Bay Community College Foundation to support the college and its mission. Van was a founding member of the Foundation and from that day on he believed TBCC was very important to Tillamook.

At Van's insistence, the Mildred Davy Endowed Scholarship, was established in 2002. With the help and support of generous donors, \$25,000 was raised; the minimum investment for all TBCC Foundation endowments. The Mildred Davy Luncheon was created that same year, and the scholarship was awarded for the first time. The Foundation has since grown to its present level, with over \$2 million dollars in

endowed scholarship funds.

When the college decided to put a bond measure on the ballot in 2007 to build a new campus Van was at the forefront of getting the bond measure passed, which it did. In 2010 Van was proud to see the new campus on Third Street open for students, and we now have a beautiful, wonderful campus that serves Tillamook County citizens. All people in Tillamook County can get a higher education right here without leaving the area. Van was the main reason I joined the Foundation Board in 2008.

A lot of the success of TBCC dates to Van Moe. His strong support for the college will be remembered. Thank You Van Moe."

## A Message from TBCC's President

Dear Friends and Supporters of Tillamook Bay Community College,

As we move through the summer months, I find myself reflecting on both the challenges and the opportunities that lie ahead for TBCC. These are times of uncertainty in higher education, and yet, they are also times of resilience, community, and renewed purpose.

At the federal level, impacts on the Department of Education have reduced its capacity to oversee civil rights protections, administer student aid, and support rural programs. This has created new hurdles for institutions like ours. Funding freezes have disrupted key grants, threatened Englishlanguage learning programs that support our migrant community, and impacted many vital programs for K-12 students throughout our county. Policy shifts have also stripped away protections for some of our most vulnerable students, many from low-income or first-generation families who already face steep barriers to success.

At the same time, state-level discussions about budget priorities remain unsettled. While there is hope for targeted investments in mental health, workforce training, and rural education, there is also pressure to tighten spending. The state budget allocation to community colleges is approximately 6% less than that needed to maintain current service levels. These realities remind us that public policy can both enable and restrict opportunity, and that those who live in rural areas often feel the effects most acutely.

These changes are not abstract. They are real. They touch the lives of our students every day: students who are the first in their families to attend college, students who juggle work, family, and school, and students who have long fought to feel like they belong. For so many of our students, the obstacles are even steeper now.

And yet, even in the face of these challenges, I remain hopeful and this is because of you.

Your support through the TBCC Foundation has been a lifeline. When federal aid is delayed or denied, your generosity ensures students can stay enrolled. When grants disappear, you help us keep vital programs running. When our most vulnerable students feel uncertain about their future, you remind them they are seen, valued, and supported. You have helped fund emergency grants for families in crisis, supported students when their access to financial aid is limited, and supported TBCC so that we can support ALL students. In so many ways, your gifts bridge the gap between what policy provides and what our students truly need.

I also find hope in the resilience of our college community. Faculty and staff continue creating new pathways to living-wage careers, adapting to a changing landscape with creativity and care. Our local partners are stepping up to advocate for education at TBCC. And every day, we see the power of education reflected in the determination of our students; whether they're earning a GED, completing a certificate, or transferring to pursue their

dreams.

Yes, these are challenging times. But they are also a reminder of why we exist – to open doors, to build opportunity, and to change lives. And with your continued partnership, that is exactly what we will keep doing.

Thank you for believing in TBCC, in our students, and in the promise and power of education. Together, we will persevere, and together, we will create a brighter future for Tillamook County.

#### ROCCS: 1,500 miles, 17 Community Colleges, 50 Days, 1 goal

The Running for Oregon Community College Students (ROCCS) campaign is a statewide awareness and fundraising initiative to highlight the challenges facing today's students and to advocate for increased state funding for essential support services. Funds raised through ROCCS will be distributed directly to participating colleges to support students' basic needs, such as food, housing, childcare and transportation.

Community college students represent some of the most vulnerable populations in the state. A survey from The Hope Center highlights the pressing needs of Oregon's community college students:

- **Food insecurity:** Approximately 41% of students reported experiencing food insecurity within the previous 30 days.
- Housing insecurity: About 52% of students faced housing insecurity in the past year, which includes difficulties such as affording rent, utilities, or frequent moves.
- **Homelessness:** Nearly 20% of students experienced homelessness in the past year, indicating a lack of stable and safe housing.

## Alumni Highlight: Maria Leos

Obtaining a GED and continuing her education had always been a dream for Maria Leos. When she moved to Tillamook in 1989, it was among the many goals she set for herself and her family. Born in Mexico and raised in the U.S. from the age of seven, Maria's story is one of resilience. She raised five children on her own while keeping her educational dreams alive. After an on-the-job injury left her unemployed, she saw it as the opportunity to fulfill a longstanding promise—to go back to school.

Maria began her GED journey at Tillamook Bay Community College by tackling math first. Drawn to its simplicity from childhood, where "two plus two" had always made sense, but algebra and geometry posed new challenges. She admits she might have guit if not for GED instructor Judy Palamores. Judy offered patient, one-on-one support, ensuring Maria grasped each concept until she passed her exams. Instructor Robert Potestio also played a key role, especially in helping her learn to write essays. "He gave me every single essay he had in his box," she said. "He made up stories just to help me learn." Their


encouragement helped turn her doubt into motivation.

"TBCC provided not only the materials I needed but the personal support I never had before," Maria shared. Tutors like Nikole Clark made a lasting impact, meeting her where she was. At age 51, Maria received her GED and walked across the graduation stage in June 2024.

Inspired to continue, she enrolled in TBCC's phlebotomy program. Her passion for healthcare was reignited while caring for her father. "He passed thinking I was his nurse," she said. "That moment made me realize I had to go for it."

Balancing school, work, and family was difficult, but with support from instructor Jodi Richardson and continued encouragement from Judy and Robert, Maria persevered. "Judy and Robert were my cheerleaders," she said. "Jodi even let me practice my first blood draws on her. I did it successfully the first time. For her to trust me, that meant the world." She graduated again in June 2025 with her Phlebotomy certificate.

Maria describes the support she received at Tillamook Bay Community College as nothing short of life changing. "TBCC made me feel so welcomed. Everybody, the staff, the teachers, from the moment I walked in here, make me feel like I'm part of the family." Now, Maria dreams of becoming a traveling phlebotomist with the Red Cross. But more than anything, she wants to inspire others to follow their dreams of receiving an education—from young people to older adults who think it's too late. "Don't let anyone tell you that you can't. If you have dreams, chase them!"
