

TBCC Commercial Driver License (CDL) Program Application

Tillamook Bay Community College (TBCC) is a registered [Federal Motor Carrier Safety Administration](#) (FMCSA) [Entry Level Driver Training \(ELDT\)](#) Provider. TBCC partners with CDL PowerSuite to coordinate program compliance, registration, attendance, student progress and course completion.

To comply with [FMCSA Documentation and Record Retention](#), TBCC will obtain, retain and share applicable records between TBCC, CDL PowerSuite, FMCSA, EQUUS, STEP/SNAP, Transport Wisdom- 3rd party tester, DMV, DOT Medical Exam Certificate, drug test results and any other necessary parties, as part of program participation. TBCC is required to retain these records for a minimum of 3 years from the date of receipt.

Please print out this application and the Student Self-Certification for FMCSA / US DOT Compliance form, complete, sign and initial as indicated and return to the TBCC CDL Coordinator.
